Welcome to Gulf Coast State College. The Dual Enrollment program provides students with an outstanding opportunity to begin pursuing their college degree or career pathway while still in high school. The Dual Enrollment Office is located in the Welcome Center of the Charles Hilton Center on the Panama City Campus. Statement of Purpose

Dual Enrollment is authorized under the Florida Statute 1007.271 as an articulated acceleration mechanism. It is intended to shorten the time necessary to complete the requirements associated with the conference of a degree, broaden the scope of curricular options available to students, and to increase the depth of study available for a particular subject. With a broad variety of courses available, students can get a head start on a career and earn high school and college credit simutlaneously.

Student Eligibility

Dual enrolled students must meet the following eligibility requirements:

- Have demonstrated prior high school academic achievement by attaining a minimum of a
 3.0 unweighted cumulative grade point average for Associate in Arts courses or a 2.0
 unweighted cumulative grade point average for career technical courses in the Associate
 of Science degree and/or certificates.
- Present qualifying designated placement test scores (PERT, SAT, ACT, CLT 10, or CLT) for computation and communication courses.
- Obtain permission of a parent/guardian.
- Provide verification from the high school guidance counselor that he/she has met the dual enrollment academic admission criteria and has a student record reflecting good attendance, appropriate conduct, and responsible behavior.
- Must complete dual enrollment courses prior to high school graduation.

Home School students eligibility is noted in the Home School Articulation Agreement.

Assessment

Dual enrollment students need to submit official assessment scores as part of the application process. Acceptable assessments include the SAT, ACT, CLT 10, CLT, and PERT. Gulf Coast State College offers the PERT each year on the high school campuses at no cost. The PERT may also be taken in the testing centers at the Panama City Campus or the Gulf/Franklin Campus. The minimum scores for entry into mathematics and English courses are as follows:

Enrollment Process

- 1. Meet with high school guidance counselor to determine program eligibility.
- 2. Apply to Gulf Coast State College as a dual enrollment student.
- 3. Submit a dual enrollment approval form to school guidance counselor for course approval. Qualifying PERT, SAT, ACT, CLT 10, CLT scores and test dates should be submitted at this time. Students who need to take the PERT (college placement test) may do so at the GCSC Testing Center. There is no charge if the student has a voucher from the high school. Home school students can get the voucher from the GCSC Dual Enrollment Office.
- 4. Submit dual enrollment registration record to GCSC Dual Enrollment Office. Some high schools will submit the dual enrollment registration record on behalf of the student.

Important Notice to Parents/Guardians and Students

Success in dual enrollment college classes is dependent upon academic readiness, social maturity, and motivation. Students who choose to participate in dual enrollment courses are subject to the same college rules, policies and public laws. Students choosing to take college classes do so with the understanding that course rigor and content is intended for a mature, college-level student.

College course-level expectations include, but are not limited to, the following:

- While appropriate for college-level study, course materials and class discussions may reflect topics not typically included in secondary courses which some parents may object to for minors. Courses will not be modified to accommodate variations in student age and/or maturity.
- The course syllabus spells out exactly what is expected of students, when assignments are due, attendance, and how students will be graded.
- It is typical to have two to three hours of homework or study for each hour spent in class in order to be successful. Assignment deadlines are firm.
- Any letter grade *below* a "C" will not count as credit toward satisfaction of

English, mathematics, and certain humanities general education requirements; however, all grades are calculated in a student's GPA and will appear on their college transcript.

- Students should consult an advisor/navigator regarding the selection of courses to meet college degree requirements.
- Poor selection of classes may result in excess college hours or impact availability of future financial aid or scholarships.
- Guiding principle: "Results count," though "good-faith effort" is important in regard to professor's willingness to help the student achieve good results, effort will not substitute for results in the grading process.
- Students who violate college rules or policies are subject to disciplinary action as provided in the Student Conduct Code found in the Student Handbook.
- Dual enrolled students must comply with the add/drop/withdrawal/attendance policies and deadlines of Gulf Coast State College (<u>Academic College Calendar</u>).
- Dual enrolled students may repeat a course in which they earned grades of W, D, or F if given permission from the high school. Third and subsequent attempts must be paid for by the student after completion of high school graduation and will be charged the full cost of instruction, which is roughly equivalent to out of state tuition. Although all course attempts appear on the transcript, only the grade earned in the most recent attempt is calculated in the GPA at Gulf Coast State College. If a student stops attending class, the grade earned, usually an *F*, is assigned and posted.
- All grades, including "W" for withdrawal, become a part of the student's permanent college transcript and may affect subsequent postsecondary admission, scholarship and/or financial aid eligibility.
- Students enrolled in the dual enrollment program will have access to the same Gulf Coast State College resources and support services as degree seeking students.

Students in need of disability services must register with <u>Student Accessibility</u> <u>Resources (SAR).</u> Students will typically need to present current documentation of their disability and complete the SAR application process.

- Dual enrollment students must maintain a 2.5 cumulative GPA on all attempted Associate in Arts degree (AA) college-level work and 2.0 cumulative GPA on all career technical college coursework each semester for continued participation in the program. If a student's GPA falls below the required GPA, he/she will be prohibited from enrolling for one semester (fall or spring). Students who fail to complete 50 percent of attempted coursework may jeopardize continued participation in the dual enrollment program. Two terms of earning a GPA below 2.5 in AA coursework and a 2.0 in career and technical coursework will result in dismissal from the Dual Enrollment program.
- Dual Enrollment courses are college-level courses. Tests are not repeated, so it is
 essential to prepare thoroughly for each exam. Please monitor Canvas regularly and
 pay close attention to assignment due dates, as late or missed work will not be
 accepted.
- GCSC is committed to a policy of honesty in all academic matters. The student code of conduct can be found in the Student Handbook.

Please check the <u>Academic College Calendar</u> for important deadlines. GCSC's fall and spring terms run on a 16-week schedule, while high school districts operate with 18-week semesters.

FERPA (Family Educational Rights and Privacy Act)

Dual enrolled students are college students and subject to the Family Educational Rights and Privacy Act. College records are not released without the written consent permission of the student with the exception of the high school to record grades on the student's high school transcript. The high school and GCSC may exchange information.

Transferring Dual Enrollment Credit

Dual enrollment credits may be used toward a Gulf Coast State College degree or transferred to state universities or private colleges. Once a dual enrollment student graduates from high school, he/she simply requests a Gulf Coast State College transcript be sent to the next institution. Students who plan to transfer to public or private institutions within the state of Florida will be able to transfer credit in accordance with established articulation agreements between Florida's community colleges and both private and public universities. The common course numbering system of the state of Florida facilitates the credit transfer process. Dual Enrollment students that want to continue at Gulf Coast State College when they graduate high school must complete the Gulf Coast State College application.

Frequently Asked Questions

Am I eligible to become a dual enrollment student? (student eligibilty)

- Have a 3.0 unweighted GPA for college credit dual enrollment or a 2.0 unweighted GPA for technical dual enrollment on a minimum of five high school credits.
- Have approval from your high school guidance counselor and parent/guardian.
- Meet the minimum testing requirements (PERT, SAT, ACT, CLT 10, CLT) for college credit classes

How do I know which courses to take?

Your guidance counselor can help you select the courses you need to graduate high school and a GCSC navigator can help you with identifying courses suitable for a designated program.

When are dual enrollment courses offered?

Students may dual enroll in approved courses during school hours, after school hours, online, and during the summer term. (Courses are offered at the high school and on a GCSC campus.)

Are certain courses off-limits?

Students cannot claim double credit for both a dual enrollment and an advanced placement course. Students are not permitted to enroll in college preparatory courses, orientation courses, physical education courses, courses in which the primary focus is the development of

individual performance skills (such as private music or voice lessons), or courses that are part of limited access programs, in accordance with Florida Statute 1007.271.

Are the dual enrolled courses taught at the high school the same courses taught on the college campus?

Gulf Coast State College's commitment to teaching excellence is reflected in the Dual Enrollment program. Course content, requirements, and evaluation components are identical to those of academic courses taught at the college. Faculty selected to teach dual enrollment, whether employed by Gulf Coast or the school district, meet teaching credentials established by the Southern Association of Colleges and Commission on Colleges (SACSOC). Additionally, instructors are approved by the applicable academic department chair.

How do I register?

Meeting with your high school counselor is the first step unless you are home schooled. Home school students should complete the Dual Enrollment Home School <u>Articulation Agreement</u> and then contact GCSC Dual Enrollment Program for an appointment.

How are grades recorded?

Grades are recorded on the college transcript and on the high school transcript.

What does dual enrollment cost?

There is no charge for tuition! Dual enrollment students are exempt from the payment of registration, matriculation, and laboratory fees.

Who pays for the textbooks?

For public/charter school students, the school provides textbooks to dual enrolled students for fall and spring terms. After successfully completing the college course, the student must return the textbook to their school. For summer terms, students will be loaned textbooks from GCSC free of charge and the textbooks must be returned pior to the start of the fall term. Private and Home school students are provided a voucher from GCSC for their textbook; the textbook must be returned at the end of the term. (Please check with your school district's policy regarding textbooks for off-campus dual enrollment courses or early admission status.)

Transportation

Transportation to and from the college is the responsibility of the studentDual enrolled students enrolled in six or more credit hours can ride the Bayway Transit system free of charge by presenting their Gulf Coast State College photo ID. What Service District Area does GCSC serve?

The College serves Bay, Gulf and Franklin Counties.

Do I need a student ID?

Dual enrolled students are recommended to obtain a Gulf Coast State College photo ID. This ID is available at the Information Desk located on the first floor of the Robert L. McSpadden Student Union East. Students need to have a copy of their current schedule and their student ID number to get a photo ID.

Do I need a parking decal?

Dual enrolled students are required to obtain a parking decal for their vehicles, if they wish to park on the College campus. This decal is available at the Information Desk located on the first floor of the Robert L. McSpadden Student Union East. Students are issued one new parking decal each academic year which will be valid until July 31. To receive your parking decal, you must bring your student ID and your license plate number, vehicle registration or a photo of your license plate.

Definitions

Career Dual Enrollment - Career dual enrollment is limited to students who are enrolled in college credit courses leading toward a degree or career and technical certificate courses or programs that each lead to an approved industry certification on the CAPE Industry Certification Funding List or CAPE Postsecondary Industry Certification Funding List described in F.S. 1008.44, F.S. 17.

Dual Enrollment - Any high school student who is enrolled in a Gulf Coast State College course and receiving **both high school and college credit** for the course is considered a dual

enrollment student. The student may be full-time or part-time, and may take classes at the high school or at Gulf Coast State College. The key factors are:

- 1. The student has not yet graduated from high school.
- 2. The student is receiving both high school and college credit for the course.
- 3. The student meets the eligibility requirements for dual enrollment.
 - Have demonstrated prior academic achievement by attaining a minimum of a 3.0 unweighted cumulative grade point average for Associate in Arts courses or a 2.0 unweighted cumulative grade point average for career technical courses.
 - Dual enrollment students must maintain a 2.5 cumulative GPA on all attempted AA college-level work and 2.0 cumulative GPA on all coursework.

The eligibility and application requirements for dual enrollment include a counselor recommendation, a parent signature, assessment scores (SAT, ACT, CLT 10, CLT, or PERT), and a completed Dual Enrollment Registration Record. **Tuition is waived for dual enrollment students.**

Early Admission Dual Enrollment Students - Early admission is a form of dual enrollment through which eligible students enroll at Gulf Coast State College on a full-time basis in courses that are creditable toward the high school diploma and the associate degree and have permission to take all coursework at Gulf Coast State College's Panama City Campus, the Gulf/Franklin Campus, or the North Bay Campus. Candidates for this program need to submit the "Application for Early Admission" and an early admission course approval form completed by the high school. Participation in this program is limited to students who have completed a minimum of 6 semesters of full-time secondary enrollment, including studies undertaken in the ninth grade.

Early College Dual Enrollment Students - An Early College Program is a structured high school acceleration program in which a cohort of students is enrolled full-time in

postsecondary courses toward an associate degree. The early college program prioritizes courses applicable as general education core courses under F. S. <u>1007.25</u> for an associate degree or a baccalaureate degree. Candidates for this program need to submit the "<u>Application for Early College</u>" and an early admission course approval form completed by the high school.

Early-Out Student Admission - Students designated as early-out graduates (meet all high school graduation requirements early) can register at GCSC as a non-degree seeking student. Early-out students are required to meet all GCSC admissions requirements and upon admission must provide a letter from their high school counselor stating the student has met all graduation requirements and giving permission to register early. Early-out students are required to pay their own fees. The official high school transcript is required when the standard high school diploma is posted.

Private/Home Schools

Students attending private schools or home schools in Bay, Gulf, or Franklin counties may participate in dual enrollment with Gulf Coast State College if their school has a signed articulation agreement on file. These students will attend classes at Gulf Coast State College.

Student Services
